RE: New Felony Appeal Notice Format

Recently, the Central Criminal Appeals Unit revised the format of the Notice to Prepare Transcript on Appeal (Felony).

We understand there has been some confusion among reporters regarding calculation of the due date. Felony appeal transcripts are due 50 days from the "Notice of Appeal Filed" date listed on the notice. This information can be located in the top middle of the notice in a box entitled "Notice(s) of Appeal Filed," which is directly above "The People of the State of California." ***The due date should not be calculated based upon the "filed" stamp date of the deputy clerk.*** Attached hereto is a copy of a blank notice with the correct box highlighted in yellow.

Other changes to the notice include the area where the reporters and dates of proceedings are listed, a column on the right-hand side indicating whether the reporters/dates of proceedings have been amended, and language in the center of the notice indicating whether the notice is "Corrections/Augmentations Only."
